## 2017 Medicare Part B Premiums

The Centers for Medicare and Medicaid Services (CMS) announced the 2017 premiums for Medicare Part B programs. For most Medicare beneficiaries already collecting Medicare benefits, there will be a small increase in these premiums. To offset this, there will be a modest 0.3 percent Social Security cost-of-living increase in 2017. A “hold harmless” provision prevents Medicare Part B premiums from increasing by more than the Social Security COLA amount for the approximately 70 percent of Medicare beneficiaries that are already enrolled.

The Medicare Part B monthly premium will rise to \$109 in 2017—an increase from the previous premium of \$104.90—for most retirees who are currently receiving benefits and earned less than a certain amount in 2015. Retirees will only pay a different premium amount in 2017 if they meet one of these four conditions:

- They enroll in Medicare Part B for the first time.
- They do not receive Social Security benefits.
- They have both Medicare and Medicaid, and Medicaid pays their premiums.
- Their modified adjusted gross income (AGI) as reported on their 2015 IRS tax return is above a certain amount.

If you're in one of the above groups, to determine how much your Medicare Part B premium will be, find the scenario that best describes your 2015 tax return filing below:

File Individual Tax Return	File Joint Tax Return	You pay in 2017
\$85,000 or below	\$170,000 or below	\$134.00
\$85,001–\$107,000	\$170,001–\$214,000	\$187.50
\$107,001–\$160,000	\$214,001–\$320,000	\$267.90
\$160,001–\$214,000	\$320,001–\$428,000	\$348.30
above \$214,000	above \$428,000	\$428.60

The Social Security Administration (SSA) uses the income reported two years ago to determine a Part B beneficiary's premiums. Thus, the income reported on a beneficiary's 2015 tax return is used to determine whether the beneficiary must pay a higher monthly Part B premium in 2017. If a beneficiary's income decreased significantly in the past two years, he/she may request that information from more recent years be used to calculate the premium.

For those members receiving post-retirement medical benefits paid for by the state of New Jersey, the standard Medicare Part B premium for them and their dependents is reimbursed in the member's pension check. Any income-related adjustment, or for new enrollees with a higher premium that a member or his/her dependent pays, is reimbursed at the end of the year in which the adjustment is paid, after the proper paperwork is filed with the Division of Pensions and Benefits.
